## FOUNDATION HIGHLIGHTS

### *Awarding Grants*

The Sundt Foundation awards over \$4 million annually in grants to nonprofit organizations. Grants range from \$2,500 to \$25,000 and are distributed quarterly. Funding is sourced from employee-owner contributions, which are matched dollar-for-dollar by Sundt. Local committees made up of employee-owners review applications and recommend funding decisions for their communities.

### *Fundraising Tournaments*

Since 2001, the Sundt Foundation has hosted special fundraising events, such as golf tournaments, fun shoots, and seasonal fundraisers, to support local nonprofit organizations. These events, held in multiple cities, have raised over \$4 million for various charities, all selected by employee committees.

### *Volunteer Projects*

The Foundation actively supports and organizes community service events for employee-owners to give back through volunteerism. We also encourage employees to record the volunteering they do on their own time so we can measure the collective impact that Sundt has in the community, both on and off the clock.
